MOTION TO SUPPLEMENT RECORD

¶ 1 Pursuant to Rule 31.8 of the Arizona Rules of Criminal Procedure, Appellee moves this Court to supplement the Record on Appeal to include the following:

1. A copy of the State's initial disclosure to Appellant, dated Oct. 2, 2008.
2. Transcript of December 29, 2009, hearing. Court reporter: Denise Warren.

Appellant argues on appeal that the State did not meet its discovery obligations before trial. The initial disclosure packet provided to Appellant, which does not currently appear in the record, is relevant to that argument. The parties discussed

the issue below at the December 29, 2009, hearing. That Appellant possesses a copy of that transcript is demonstrated by his references to it in the Opening Brief. (See Opening Brief at ¶ 71.) Appellee also possesses a copy of that transcript and will need to refer to it in order to properly address Appellant's argument. However, it does not appear that the transcript in question is currently part of the Record on Appeal. For the Court's convenience, Appellee has attached copies of each document to this motion.

¶ 2 Neither the parties nor this Court can fairly resolve the issue presented by Appellant without a full record of the proceedings below on the issue. Accordingly, Appellee respectfully requests that this Court order that the record be supplemented as requested.

COMES NOW the Pima County Attorney, BARBARA LAWALL, pursuant to Rule 15 of the Arizona Rules of Criminal Procedure and provides those matters discoverable which may be used as evidence in the State's case-in-chief and as rebuttal evidence in the above entitled case. Further, the State hereby discloses an "open case file" policy. Defense counsel may make arrangements with the assigned attorney to view the State's file.

1. Defendant's Statements

The State will use any of the defendant's statements, including those which are summarized or alluded to in the disclosure materials.

2. Experts Consulted

The State will use the testimony of any expert witness whose report is included in the disclosure materials. If the case involved breath, blood or some other bodily substance, the State will call a qualified witness to admit the results of any analysis of the substance and to testify to the effects of alcohol or drugs on the human body.

If DNA evidence is applicable in your case, be advised that the crime lab maintains written procedures and protocols governing the analysis of such evidence, including quality assurance measures and reports. These materials may be obtained by contacting the assigned prosecutor or the crime lab directly. Laboratory personnel are available for interviews concerning said procedures, protocols and quality assurance measures and reports.

3. Physical Evidence

The State will use any items listed in or referred to in the disclosure materials, Indictment/Information, Grand Jury transcript or Preliminary Hearing transcript. The State will also use all photos, charts and diagrams, as well as any financial or business records applicable to the case.

4. State's Witnesses

The State will use any witnesses named or referred to in the disclosure materials. Additionally the State will call any witness necessary to prove the defendant's prior convictions and/or that (s)he was in violation of his/her release status.

5. Defendant's Prior Felony Convictions

The State will use all of the defendant's prior convictions both during the trial and sentencing phases. In DUI cases, any misdemeanor or felony prior conviction for Driving Under the Influence will be introduced at trial. Documentation of the prior convictions are at the Pima County Attorney's Office and may be reviewed during normal business hours.

7. Availability of Recorded Data

Data such as 911 tapes, radio logs / incident history, and radio transmissions are available for review upon written request. The time limits are as follows: DPS and Tucson Airport Authority: 60 days post incident date; PCSD and Tohono O'odham PD: 6 months post incident date; Tucson Police: 90 days post incident date; and UofA PD: 90 days post incident date. Requests for data should be made at least thirty (30) days prior to the scheduled date of destruction.

3. Physical Evidence

The State will use any items listed in or referred to in the disclosure materials. The State may use photographs, charts or diagrams including, but not limited to, a diagram of the scene, a diagram or any device used to analyze a defendant's bodily substance, police officer certifications, the alphabet or number field sobriety test, and any photos taken of the defendant. If the defendant was videotaped, the tape is available to you through the Pima County Attorney's Office. The State may also use both known and unknown samples or exemplars of fingerprints, palm prints, footprints, voice, handwriting, hair, blood, saliva, or urine to prove identification pursuant to Rule 15.2(a).

9. DEMAND FOR DEFENSE DISCLOSURE

ON 9-7-08 I RESPONDED TO 3234 E BELLEVUE IN REFERENCE TO AN UNKNOWN TROUBLE CALL WHERE A MALE WAS SCREAMING FOR HELP. I responded to the listed location to assist officers reference a shooting victim. Upon arrival I assisted with securing the area. I then spoke to the listed witnesses Fernando Olague and Patricia Trevino.

Fernando stated that he had heard a male and female in apartment number 2202 arguing since around 0300hrs. He told me that he knows them as Nicole and John. He stated that he had heard them arguing often. He said between 0625hrs and 0630hrs he heard a single gunshot. He said the gunshot sounded like it came from a small caliber handgun. Afterward he heard a door slam and then heard a male screaming "Nicole", "Oh god" and "No baby." He opened his door and saw John outside of his apartment. He was holding Nicole and performed CPR. Fernando said a second male exited the apartment and stated, "Grab her let's take her to a hospital." Fernando told them to leave her where she was. Fernando did not know the other male by name but he told me that he lived with John and Nicole. Fernando advised me that he had called 911 using John's phone.

I spoke to Patricia. She stated that she had heard arguing throughout the night. Patricia said she could hear both a male and female say "I'll kill you." She heard a gunshot between 0600hrs and 0630hrs. She stated that the gunshot sounded like it came from a handgun. She then heard a male yelling. She said her fiancé Fernando went outside and she saw a male putting pressure on a female's chest.

I later stood by with Josh Ramirez until detectives arrived and spoke with him. While I was with Josh he stated, "He fucked up" and "His life is over" multiple times. He also stated, "Their cell phone will tell you everything, they were arguing last night." He also said, "She threatened to commit suicide", "The bathroom door was bashed in" and "My cousin told me to stay out of it."

I later stood by at apartment 4202 until detectives advised I could clear. That concludes my involvement in this case. NFI.

NARRATIVE

Officer Pruitt (45469) and I responded to 3234 E. Bellevue reference an unknown trouble, a female had appeared to be shot or stabbed and a male subject was screaming and pressing on the wound to stop the bleeding. Upon arrival I observed Officer Huesgen (31566) at the top of the staircase landing giving a female subject chest compressions who appeared to have a gunshot wound and was bleeding from the chest. A male subject was seated behind Officer Huesgen screaming to save her life. Officer Pruitt removed the male subject from the top of the staircase landing and took him downstairs where Officer Nottingham (50471) detained him. Officer Altman (50451) and I searched apartment #2202 for possible suspects with negative results. During the search of the apartment for possible armed suspects, I observed the entire apartment to be disorderly and unclean. The living room had compact discs and garbage scattered throughout the floor. Officer Pruitt located the victim's identification from her purse on the couch in the living room.

I contacted the resident in apartment #2201, Cynthia Moore (11/30/52, 312-3680). Moore stated she heard what she thought was a gun shot (was not positive it was a gunshot) and heard John (Jonathan Swihart) calling 911 in the apartment and stated she did not see any of the incident between John and Nichole (Nichole Renea Katz). The other resident, Michael Coleman (05/26/77) did not hear or see anything, but stated there are three residents who live in the Apt #2201, John, Josh and Nichole. Coleman stated John and Josh were cousins and had an Uncle that lived in the apartment complex at #3402.

James Plough made contact with Officer Huesgen and myself and stated his nephew (Jonathan) was the male subject that was detained and his other nephew (Joshua) was located in his apartment #4202. Plough took Officer Huesgen, Officer Pruitt and I to his apartment where we made contact with Joshua Ramirez. Upon entering in apartment, Ramirez was lying on the living room crying. Gabriella Philbioak and Ruby Plough were also in the apartment at time of contact. Ramirez was detained and placed in the backseat of a patrol vehicle where I remained with him until relieved by Sgt. Trusko (36817).

I remained on scene and provided scene security. I assisted OME with removal of Katz's body. Officer Pruitt removed Swihart's keys and identification from his left pants pocket before he was placed into Officer De La Ossa's (44423) patrol vehicle. This concluded my involvement with this investigation.

HE SPOKE VERY SOFTLY AND I COULD NOT HEAR HIM. HE THEN YELLED OUT "I DIDN'T MEAN TO SHOOT HER, I LOVED HER SO MUCH." WHEN WE ARRIVED AT THE STATION, HE WAS PLACED IN AN INTERVIEW ROOM WHERE DETECTIVES CONDUCTED THEIR INVESTIGATION. NFI

NARRATIVE

On 09/07/08 I responded to 3234 E Bellevue #2202 to assist in reference to an unknown trouble. Upon arrival I made contact with Jonathan Swihart at the base of the apartment stairwell.

He was yelling out for Nicole and was crying. I stayed with him while others officers on scene attended to Nicole and secured the scene. After the paramedics arrived he stood up and tried to run closer to the stairs, he was not listening to verbal commands to remain seated and Sgt. Trusko #36817 and I detained him by putting our hands on his shoulder blades, keeping him on the ground. He continued to yell things like, "please god, take me" and "save her, work on her, give her oxygen;" he swung his shoulders away from us, stood up again and lunged forward towards the stairwell. Sgt. Trusko and I regained control of him; he was handcuffed with his hands behind his back and seated. He punched the cement with his fists and yelled, "fuck you, leave me alone, save Nicole." A short time later he swung the handcuffs in front of his body and lunged forward from the seated position. He stayed low to the ground but attempted to make his way to the stairs once more; I grabbed his waist and used his body leverage to bring him back down to the ground. The handcuffs were switched from the front of his body to behind his back and he was taken to a patrol vehicle.

At the patrol vehicle Officer Pruitt #45469, Sgt. Trusko, and I removed his property from his pockets. I removed cigarettes and a lighter from his right pocket. He was placed into a TARP and secured inside the vehicle. A few minutes after he was placed inside the vehicle he removed the TARP from his legs, swung the cuffs to the front under his legs, and tried to reach for the exterior door handle from the partially opened window. He was removed from the vehicle, the handcuffs were switched to the back and he was secured in the TARP again. His grandmother came to the vehicle and told him that his parents were on the way. He asked her if Nicole was dead and she said she did not know and that she loved him. She then walked away from the patrol vehicle he was in. As I monitored Jonathan inside the patrol vehicle I heard him say, "fuck, I didn't mean it, please let her live," and, "just fucking kill me, do that suicide by cop shit, shoot me in the fucking head." He also used his head and butted the plexiglass screen in the patrol vehicle numerous times. The head butting resulted in a small knot on his forehead that was later photographed.

Officer De La Ossa #44423 and I were instructed by Lieutenant Greene #26737 to move Swihart from the area. He was transported around the corner to 3233 E Speedway; a short time later we were advised Detective Sgt. Hall #32623 wanted Swihart transported to the main police station and placed in the violent crimes interview room. He was transported and placed inside interview room #2; detectives arrived and interviewed Jonathan. I remained at the main police station during the interview and the subsequent photograph and ID protocols. Detective Carroll #35791 gave me the information to book Jonathan into jail. As I walked Jonathan down to the patrol vehicle for transport he asked me, "If you killed your girlfriend, would you have the conviction to kill yourself?" I transported him to Pima County Jail where he was subsequently booked. NFL.

On 09-07-06 at 0636 hours I responded to 3234 E Bellevue in reference to a male yelling for help. The call text also stated that a female had sustained a stab or gunshot wound and the male was with her.

Upon arrival Officer Huesgen, #31566 was in front of apartment #2202 on the landing and performing CPR on a white female. The female had a gunshot wound to the chest. Next to Officer Huesgen was the male who was yelling. The male was the victim's boyfriend, Jonathon Swihart. I asked the boyfriend if anyone else was inside the apartment and where the gun was. He stated that his cousin was inside with the gun. Officer Pruitt, #45469 and Officer Evans, #51066 arrived on scene. The door was already slightly open to the apartment. I opened it the rest of the way. I announced that we were the Tucson Police and if anyone was inside for them to come out. The first room was the living room. There was broken CD's and playing cards all over the floor. There was a table stand in the middle of the room that was knocked over. Officer Evans and I entered the residence to ensure that there was nobody inside with a gun or any other injured parties. There was a trail of blood from the front door to the southeast bedroom. When we went inside the room there was a door to a patio that was open. Nobody was located during the search of the house. Officer Pruitt and Officer De La Ossa came in briefly to assist in clearing the residence. We all exited the residence once we established that no one was inside that was a danger to our safety or injured.

The paramedics were present and working on the victim female when we finished clearing the residence. The victim did not have any identification on her. There was a purse on the futon, which was located right next to the front door. I picked up the purse and looked to see if the purse had any identification for the victim. Inside the purse was a small baggie of marijuana. The victim's identification was underneath the baggie in a small wallet. I took out the victim's identification and placed the purse with the baggie of marijuana back on the futon where I had located it. The victim was identified as Nichole Katz.

The victim was pronounced dead (0701 hours) and the paramedics cleared the scene. While standing outside on the landing I noticed there was a small amount of blood by the front door. There was also a cell phone and part of the door lock on the ground. The area was secured and detectives were called out to the incident. Sgt. Trusko was on scene.

I did scene security for the apartment and landing. Sgt. Hall of Homicide informed me that they would be getting a search warrant for the residence. The Crime Scene Unit responded. OME responded.

The only people to enter the apartment prior to the search warrant were: Officer Huesgen at 0703 hours and Sgt. Hall at 1036 hours because the resident beneath apartment 2202 stated that there was watering coming in through her roof and it sounded like water was running in apartment 2202. Sgt. Hall served the warrant on the residence. I stood by while they collected evidence. I stood by until Sgt. Hall and Sgt. Trusko cleared me from the scene.

I RESPONDED AS PART OF A TWO MAN TRAINING UNIT WITH OFFICER EVANS, 51066, TO THE LISTED ADDRESS REFERENCE AN UNKNOWN TROUBLE CALL. UPON ARRIVAL I OBSERVED OFFICER HUESGEN, 31566, PERFORMING CHEST COMPRESSIONS ON THE VICTIM OF A GUNSHOT WOUND TO THE CHEST. THE SUSPECT, LATER IDENTIFIED AS JONATHAN SWIHART, WAS SEATED ON THE LANDING BEHIND OFFICER HUESGEN. I REMAINED WITH HIM WHILE OFFICERS ALTMAN, 50451, AND EVANS CLEARED THE RESIDENCE. I TURNED SWIHART OVER TO OFFICER NOTTINGHAM, 50471, AND WENT UP TO THE APARTMENT TO OBSERVE OFFICER EVANS. ONCE INSIDE THE APARTMENT I OBSERVED THAT THE APARTMENT WAS IN DISARRAY. THERE WERE MISCELLANEOUS PERSONAL ITEMS ALL OVER THE FLOOR, TO INCLUDE OVERTURNED FURNITURE, A MARIJUANA BONG, LOADED HANDGUN MAGAZINE, A SHOTGUN, BROKEN AND INTACT COMPACT DISCS, ARTICLES OF CLOTHING, PAPERS, AND SOME BLOOD. NARRATIVE	

On 9/7/08, Sgt. Hall #32623 contacted me at my residence and requested that I respond to 3234 E. Bellevue, reference a homicide investigation. I arrived at the location at 0821 hours and was briefed by Officer Evans #51066. Evans stated that a Nichole Katz and a Jonathan Swihart were in apartment #2202 with Joshua Ramirez. Jonathan shot Katz and both males dragged her onto the porch area. Tucson Fire Ladder/Medic 5 responded and Katz was pronounced dead by Doctor Sackles at 0706 hours. Swihart and Ramirez were located and detained. Three witnesses, Ruby and James Plough, and Gabriela Philbrook were located in apartment #4202.

Sgt. Hall assigned the case to Detective Carroll #35791, with Detective Kelly #35801 as his secondary. I was assigned to interview witnesses in the case, and obtain a telephonic Search Warrant with Detective Kelley #26774.

I conducted taped interviews, with I am summarizing and paraphrasing here. See CD/Statements for additional information.

Ruby Plough statements: 0908 hours

- I was asleep at about 6-6:30 (a.m.) and my oldest grandson Joshua came to the door. He said, "there was a shooting. It was an accident. Jonathan was involved in an accident. He shot Nicole. I tried to stop him." My son James tried to call Jonathan and walked over there. I didn't even know if she was still alive. My grandson's live together. I haven't heard any problems between Jonathan and Nicole. I think she lives over on 22nd street.
- James came back and told me we needed to call Jonathan's mother and tell her what happened. He told me, "It doesn't look good Mom, it didn't look good." Rhonda, Jonathan's Mom was called.
- I went outside and tried to calm Jonathan down. He was freaked out. James didn't go to the boy's apartment. I couldn't calm down Jonathan, or Joshua. They were tripping out.
- Jonathan and Nicole didn't have any Domestic Violence that I know of.
- (I asked her if Joshua brought anything with him, or left anything in her apartment) She said, no. (I asked her if James did). She said, no.

James Plough statements: 0922 hours

- I was sleeping and heard a bang at my door. I opened the door and Josh came in and lay down on the floor. He seemed like he was out of it. He said, "she's dead, she's dead, I don't want to go to Prison for the rest of my life. I tried to stop them from fighting. Jonathan and Nicole were arguing all night. They were fighting."
- I thought he was joking with me. He curled up in a ball and was crying. I asked him when it happened. He said, "just now. The cops are there now." I told him he needed to talk to the cops. He said, "I don't want to go to prison for the rest of my life."
- I went over to their apartment and saw officers. Jonathan was with them. They asked if I'd seen the other guy and I told them that Joshua was at my apartment. I had tried to call Jonathan on his cell earlier, but I got no answer.

NARRATIVE

- I asked Josh what happened. He said "they were arguing all night in the room. Jonathan shot her." (I asked James if Josh was present when this happened). He said, "well I think he was in the room with them if he saw Jonathan shoot her." Joshua said that it was an accident. I didn't see Joshua with any blood on him.
- I got hold of Jonathan's Mom (Rhonda) and Dad (Dave) and told them.

Gabriela Philbrook statements:

- I came over here last night. James said I could stay here. I was sleeping and I heard a bang at the door. Some kid came in. I don't know who he was, but James knew him. The kid was freaking out saying, "I think the girl is dead." The kid lay on the floor and was breathing heavy. James asked him what happened? James asked him if he called his Dad? The kid said, "They were fighting all night and there was a shooting. I tried to get between them, but couldn't."
- James said, "I gotta go look." Ruby told me that this boy on the floor was "Joshua, her oldest grandson." James came back with the police. They handcuffed Joshua.
- Joshua never left the room. He just stayed on the floor. He didn't have anything with him when he came in.

I briefed Sgt. Hall on the interviews. Det. Kelley and I responded to the Midtown substation, 1100 S. Alvernon, and completed paperwork for a telephonic Search Warrant. I contacted Judge D. Bernini and obtained the warrant. I transported Det. Kelley back to the scene.

I cleared the scene at 1100 hours.

On 9/8/08, I returned the Search Warrant to Judge Bernini and filed the original in Superior Court.

This concludes my involvement to date.
